Dear Client:

As the end of the year approaches, I would like to make you aware of some possible year-end filing requirements. If you are self employed and you paid \$600 or more to subcontractors, freelancers, or other individuals, you are required to:

- Issue them a Form 1099 by January 31st
- Submit copies of the 1099s to the IRS by January 31st

There are penalties for late filing, incorrect filing, filing on a form that cannot be scanned, and paper filing when you are required to electronically file.

Typically, you must issue 1099s to subcontractors, your landlord, your accountant, your attorney, etc.

If you have employees, you should have filed quarterly payroll tax returns with the IRS and the state tax department. The next quarterly tax forms are due January 31st and you must also:

- Issue W-2s to all employees by January 31st
- Submit copies of the W-2's to SSA by January 31st.

The penalties for filing W-2s late are similar to the 1099 penalties.
